DIEBEL AIMS FOR U.S. CONGRESS

Taking a tall political step, Karen Diebel hopes to go from a first-term Winter Park city commissioner to the U.S. Congress. The executive director at Verizon Business says her relatively short time in public office can help her. "I'm proud that I'm not a career politician. Voters are looking for leaders with real-world experience. In my case, as a businesswoman, I can bring real leadership to issues that face our economy, like securing jobs, reducing wasteful spending and keeping taxes low," said Diebel, who joined the City Commission in 2007.

The 42-year-old Republican will challenge incumbent Rep. Suzanne Kosmas, D-New Smyrna Beach, for District 42 in the 2010 election. "There is a stark contrast between me and Congresswoman Kosmas on a wide spectrum of issues, but the most important distinction so far has been our differing positions on the so-called "stimulus" plan: She voted for it and I would have voted against it," Diebel said. Her three-year term on the City Commission ends March 2010, and the congressional primary is in August.

In 2004 she co-founded the N. Donald Diebel Jr. M.D. Good Samaritan Fund in memory of her husband who was killed in 2002 on Florida's Turnpike as he was trying to help motorists who were in an accident. She has three sons.
